NURSING AND RESPIRATORY THERAPY SUPPORT FROM:

BCCH PEDIATRIC INTENSIVE CARE UNIT (PICU) and VGH PICU OUTREACH NURSE (Island Health)

CCON can be reached as a resource for nurse-led advice on topics for patients aged 0 - 18 years

DO NOT delay activating Pediatric Code Blue or contacting MRP if you have immediate concerns. For urgent critical care needs or patient assessment, use the physician-to-physician process.
